## Amendment II

**A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.**

Ethan Allen



On January 21, 1738, Ethan Allen, future Revolutionary War hero and key founder of the Republic of Vermont, is born in Litchfield, Connecticut.

Ethan, the oldest of seven children, took over the family landholdings. Two years later, Ethan made his first visit to the New Hampshire Grants, land that is now within the state of Vermont, as part of the

Litchfield County militia during the Seven Years' War.

Having acquired land in the area, in 1770 Ethan Allen became the colonel-commandant of the Green Mountain Boys, a militia founded in what is now Bennington, Vermont, to defend the New Hampshire Grants. In an inter-colonial fracas, both New Englanders, like Allen, and colonial New Yorkers claimed land in the Green Mountains. Although Allen's vigilantes took no lives, they were willing to use lesser forms of physical intimidation to scare New Yorkers into leaving the area.

Allen and his boys proposed political independence for their district between the Connecticut River and Lake Champlain before the American Revolution caused their attention to shift towards independence from Britain. In 1775, Allen and the Green Mountain Boys captured Fort Ticonderoga from the British in a joint effort with Colonel Benedict Arnold, who had been commissioned by Massachusetts and Connecticut to stage an attack to prevent British forces from marching on Boston. The same force took control of Crown Point, New York, the following day without facing any opposition. The two easy victories garnered for the Patriots much-needed cannon that they then used to drive the British from Boston. Later in the year, the British captured Allen during the botched Patriot attempt to seize Quebec.

Ethan Allen died on his farm along the Winooski River in the still independent Republic of Vermont on February 12, 1789. Two years later, Vermont finally managed to join the new republic as its 14th state.

## The Law, What Is Going On?

Right now there is nothing going on at the State level here in Florida. The Federal level is a different story.

Right now in Congress there are two bills that are of interest to gun-owner, one good and one bad.

### The Good -- H.R. [6945](#) (IH) - No Retaining Every Gun In a System That Restricts Your Rights Act

#### Full Title

To amend title 18, United States Code, to discontinue the collection by the Federal Government of firearm transaction records of discontinued firearms businesses, to require the destruction of such already collected records, and for other purposes.

The full title pretty much lays out what the bill is about. It is an attempt to keep the ATF from compiling what amounts to a gun registry.

### The Bad – H. R. 1808/S. 736 -Assault Weapons Ban of 2021

The House has already passed their version of the Bill. It now awaits the Senate. Joe Biden and the Democrats desperately want to get this Bill passed so don't be surprised if there is a major mass shooting incident in our near future.

#### Summary of [S. 736](#)

This bill makes it a crime to knowingly import, sell, manufacture, transfer, or possess a semiautomatic assault weapon (SAW) or large capacity ammunition feeding device (LCAFD).

The prohibition does not apply to a firearm that is (1) manually operated by bolt, pump, lever, or slide action; (2) permanently inoperable; (3) an antique; or (4) a rifle or shotgun specifically identified by make and model.

The bill also exempts from the prohibition the following, with respect to a SAW or LCAFD:

- importation, sale, manufacture, transfer, or possession related to certain law enforcement efforts, or authorized tests or experiments;
- importation, sale, transfer, or possession related to securing nuclear materials; and
- possession by a retired law enforcement officer.

The bill permits continued possession, sale, or transfer of a grandfathered SAW, which must be securely stored. A licensed gun dealer must conduct a background check prior to the sale or transfer of a grandfathered SAW between private parties.

The bill permits continued possession of, but prohibits sale or transfer of, a grandfathered LCAFD.

Newly manufactured LCAFDs must display serial number identification. Newly manufactured SAWs and LCAFDs must display the date of manufacture.

The bill also allows a state or local government to use Edward Byrne Memorial Justice Assistance Grant Program funds to compensate individuals who surrender a SAW or LCAFD under a buy-back program.

ATF

Under the Biden administration and the new ATF Head Steve Dettelbach, the agency has been weaponized.

The ATF is establishing new rules and procedures.

The so called "Ghost Gun" rules just went into effect on August 24<sup>th</sup>. The rule:

Today, the Department of Justice Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) "Frame or Receiver" Final Rule goes into effect. The new rule modernizes the definition of a firearm and makes clear that parts kits that are readily convertible to functional weapons, or functional "frames" or "receivers" of weapons, are subject to the same regulations as traditional firearms. This rule will help curb the proliferation of "ghost guns," which are often assembled from kits, do not contain serial numbers, and are sold without background checks, making them difficult to trace and easy to acquire by criminals. If you are not already a member of U.S. LawShield I strongly suggest that you join as soon as possible by going to the [SACFLA](#) website and signing up for about \$12 dollars a month [Link](#). On our home page scroll down a bit and you will see the U.S. LawShield signup link.

The ATF has also been showing up at the homes of individuals that have purchased 2 or more guns at a time demanding that they see them again without a warrant. In this case they have no authority. You don't need to comply unless they have a warrant. Simply tell them they need a warrant to make that request.

OKLAHOMA GOVERNOR SIGNS BAN ON 'RED FLAG' GUN SEIZURE LAWS

Republican Gov. Kevin Stitt on Tuesday signed a bill that would bar cities and counties in Oklahoma from enacting so-called "red flag" gun seizure schemes.

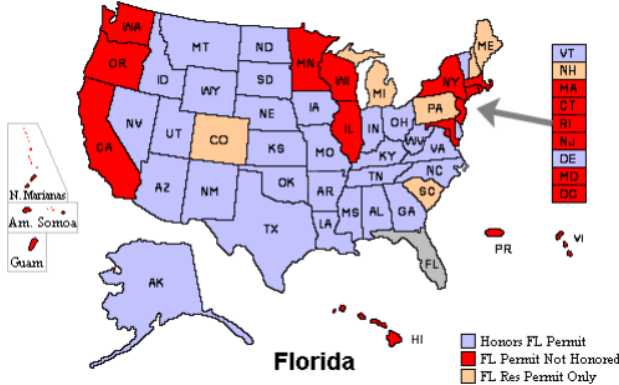
Stitt put his signature this week on Oklahoma Senate Bill 1081, the "Anti Red Flag Act," which preempts any type of extreme risk protection legislation in the state. The measure was popular with lawmakers, passing the state Senate 34-9 and the state House 77-14.

The measure had the support of state and national pro-gun organizations to include the Oklahoma 2nd Amendment Association and Gun Owners of America. Such groups argue red flag bills have little impact on crime and instead force individuals to surrender legal firearms to law enforcement based on often uncorroborated statements, then putting those gun owners into an expensive uphill fight to get their rights restored.
